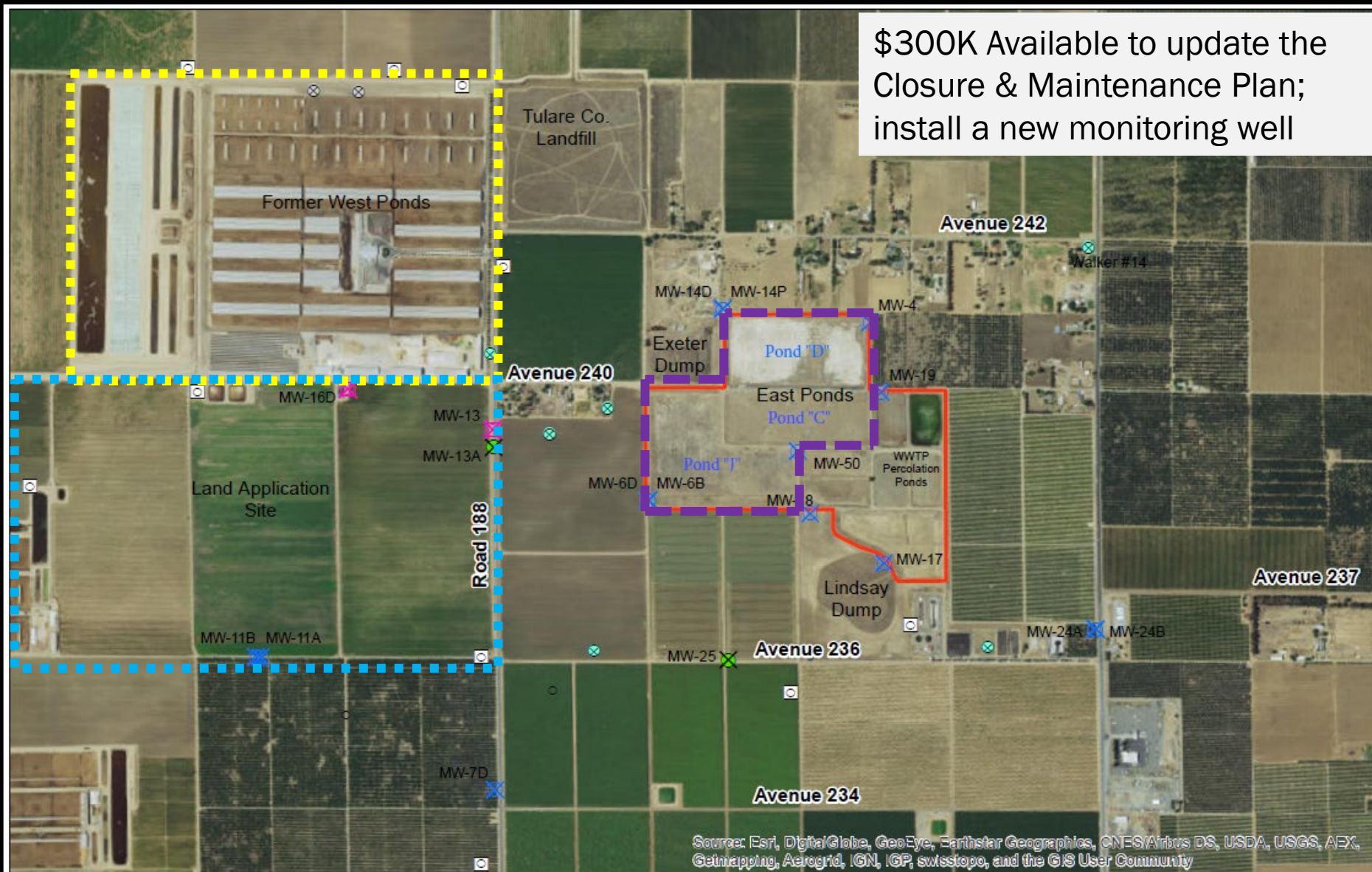


Lindsay Olive Growers East Pond Closure

Cleanup & Abatement Order No. R5-2004-0715

- ❖ Olive Plant Discharge
 - LOG=Lindsay Olive Growers
- ❖ WWTP Ponds
 - Referred to as LOG East & West Pond Sites
- ❖ West Ponds were closed by Sierra Cattle Company and Hilarides Dairy was constructed on this property.
- ❖ East Ponds were lined between 1967 and 1974 w/ 1-foot-thick low permeability soil layer overlain by a 10-mil polyethylene membrane liner.
- ❖ Leakage was discovered and East Ponds were retrofitted in 1983 w/2-foot-thick low permeability soil layer overlain by a 30-mil polyvinyl chloride along the bottom areas and 36-mil Hypalon on the embankments.

\$300K Available to update the Closure & Maintenance Plan; install a new monitoring well

Lindmore Street Rehabilitation Project – Tulare County Partnership.

- Council entered into an agreement with Tulare County to rehabilitate Lindmore St from HWY 65 to Foothill Ave back on September 27, 2022. Lindmore St was part of a large street package that included 15 other locations throughout the county.
- The project got awarded and began construction in the Fall of 2023. Due to weather conditions, construction was put on hold, it restarted at the end of February 2024. The County provided an updated schedule and construction is set to start on May 30, 2024
