## **HISTORY**

- I have 20 years' experience in running a market with over 700 spaces; I maintain a 99-100% capacity all year round. I kept the Lindsay Market at capacity, as well.
- I put in my Request for Proposal once it was opened to the public in 2019. I scored 91% overall, in the different categories. My score was higher than the other two candidates whose scores were in the 50's to 60's percentile. These percentages were made public. The Mayor and City Council Members unanimously voted me in as the new operator of the Lindsay Friday Night Market.
- The first year was exciting and it took little time to settle in and for people to settle down to my new management. Most vendors were the same ones that were with the Chamber of Commerce. Some vendor spaces were moved around to distance themselves from other vendors who sold similar items, but basically it stayed the same.
- When I was preparing to open the market the City Manager, and the Department of Services made it clear the Chamber of Commerce were provided, free of charge, many items necessary to run the market. I was advised I would not enjoy the same amenities.
- During the first year I purchased light generators, a dump trailer and dually truck. I purchased my own Porta-Potties and handwashing units, garbage receptacles and all manner of equipment and essentials needed to run the market successfully. I paid a professional plumber twice to replace the faucet at the public bathrooms; I see it has been vandalized again.

## **CURRENT OPERATIONS**


- I rehired 7 of the people that had previously worked with the Chamber of Commerce at the market. 6 of these people are still with me and want to continue to work with me in the market.
- I have always fulfilled my monthly financial agreement to the City. Even the first and only market day on March 6, 2020, was paid in full despite the pandemic.
- Ultimately my focus is on the people. As such, I help a non-profit Food Ministry that, before the pandemic, served over 4000 families a month. The people working the beer booths are volunteers of that Food Ministry. I donate to this organization. My plan is to serve them again in the same capacity post-pandemic.

## **FUTURE PROJECTS**

- My objective is helping the whole community, not just individuals. I maintain no-fee spaces for local community organizations to promote information like health clinics, Girl's, and Boy's Scouts, just to name a few. I have confirmed with Tulare County spaces for information booths and future vaccine clinics for Covid-19. It is the perfect venue to help our Valley.
- I will be hiring more security for the market. A total of 8 guards in the street and 1 guard each dedicated at the beer point of sale booths for the safety of the volunteers. To date, any issues have been timely resolved through working closely with Lindsay City officials.

#### 3. PLEDGE

#### 4. PUBLIC COMMENT

- Mercy Herrera of the Lindsay Chamber of Commerce spoke regarding the need to support local
  vendors and businesses; Ms. Herrera is concerned that the change in operations management for
  the Friday Night Market has led to the exclusion of certain vendors; Mrs. Herrera would like
  Council to review the current contract in light of these concerns.
- Resident did not give her name and provided her comment in Spanish which was translated in real time by the City Clerk. She expressed a desire to return to work and to do so in a manner consistent and supportive of City rules. She identified herself as a vendor at the Friday Night Market who was happy with the way the market was run previously under the leadership of Virginia (no last name provided). Resident felt that after market operations changed, there were many instances of disrespect on the part of market operators towards vendors like herself.
- Resident did not give his name but identified himself as the owner of a local business, Las
  Palmitas; his comment was provided in Spanish and translated by the City Clerk in real time. The
  resident described how when Friday Night Market operations first changed, he was not happy

about it and expressed that; because of that choice he felt he had suffered negative repercussions from the current market operators. The resident's participation at the market has since been revoked, and he remains unhappy with market operations. He also echoed the lack of respect in the market operators' dealing with vendors. He is not in support of a proposed change to operations from "market" to "swap meet" as it would require that vendors take on many upfront costs without knowing for how long the market would be operating as a "swap meet." He feels that the current market operators have not acted in good faith, there had been unfair exclusions of vendors, and lack of notifications about meetings. He feels he has not received workable solutions or support in the past and does not feel valued in Lindsay; he has considered closing his business.

• Resident did not give his name. He was concerned regarding road safety conditions at Hermosa and Homassel. Because of the Healthy Start location and nearby schools, the area is heavily traversed by many kids and families. Although he's aware the City has done some street patching, he thinks it needs more than that and should be repaved.

#### 5. COUNCIL REPORT

- Council Member SERNA reported regarding the ongoing vaccine drive at the Wellness Center; Rite Aid is also another vaccination site in town currently offering appointments.
- Mayor Pro Tem FLORES wished Council Member CERROS a Happy Birthday. She also expressed gratitude to the long-serving members of staff for their loyalty to the City and thanked the newer members such as the City Manager and City Clerk for their hard work.

#### 6. CITY MANAGER REPORT

- Tulare County has officially moved into the "orange" tier based on the state's COVID-19 metrics.
- Governor Newsom has announced a state reopening date of June 16, 2021. It is unclear yet what
  this means for City operations, but the City will keep tabs on any further communications from
  the State.
- The most recently passed stimulus package has allocated 2.5M in funding to the City; roughly half of the General Fund budget. The Treasury Department is rolling out additional guidance that will inform the City's flexibility in spending parameters and auditing reporting requirements for City uses.

#### **ACTION & RECOMMENDATION**

No action requested; information item only.

#### BACKGROUND | ANALYSIS

The quarterly notification for Disinfection By Products (DBP) is a requirement of the State of California Water Resources Control Board (DWR). This is the second quarter notification for 2020 and as long as our system exceeds the maximum contaminant level (MCL) for DBP, quarterly notification will be required by DHS. The first notification was released January 2017 (for fourth quarter of 2016).

The template for this letter was provided by the DHS. It is their approved language; we update this notice with our sample result values, in a running annual average.

While the system exceeds the MCL for DBP, the notice states that this is not an emergency and that an alternate source of water in not needed. It also points out that persons with specific health concerns consult their doctor.

Disinfection byproducts are chemical, organic and inorganic substances that can form during a reaction of a disinfectant with naturally present organic matter in the water. Byproducts that are regulated are Total Trihalomethane (TTHM) and five Haloacidic acids (HAA5). The DBP's are a result of our primary chlorine disinfection process of surface water.

Provost & Pritchard completed a detailed technical study to analyze best options to resolve this DBP issue by July 2020. The study was funded by Tulare-Kern Integrated Regional Water Management, Disadvantaged Community Funding Committee (Tulare County is the funding administrator). The funding amount is \$70,500. The study is expected to serve as basis for future construction funding as well. The study was submitted to the State of California Water Resources Control Board for comment. The study confirmed relocation of our primary disinfection point from the Friant Kern Canal to the current chemical injection point at the water treatment plant as the supported mitigation project.



Staff continues to explore options of funding for the mitigation project. The estimated project costs were \$343,500. Options of funding include State Revolving Funding program and/or Integrated Regional Water Management Implementation Grant program. Both programs could take 12-18 months to secure funding, if approved.

## **FISCAL IMPACT**

City staff continues to pursue funding for the selected mitigation project, including possibility of Rescue Plan funding.

#### City of Lindsay has levels of Disinfection Byproducts Above Drinking Water Standards

Our water system recently failed a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what you should do, what happened and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Test results continue show that our system exceeds the standard or maximum contaminant level (MCL), for Total Trihalomethane (TTHM) and/or 5 Haloacidic Acids (HAA5). The MCL standard for THM is 0.080 ug/L and for HAA5 is 0.060 ug/L. The running average level of TTHM and HAA5 over the last year at each site is listed below;

#### What should I do?

You <u>do not</u> need to use an alternative (e.g., bottled) water supply. This is not an immediate risk. If it had been, you would have been notified immediately.

Some people who drink water containing TTHM's in excess of the MCL over many years may experience liver, kidney, or central nervous system problems, and may have an increased risk of getting cancer. Some people who drink water containing HAA5's in excess of the MCL over many years may have an increased risk of getting cancer.

If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

#### What happened? What was done?

Disinfection byproducts (TTHM and HAA5) are chemical, organic and inorganic substances that can form during a reaction of a disinfectant with naturally present organic matter in a water supply. TTHM and HAA5 samples are collected each quarter and a running annual average (RAA) is calculated for compliance.

The City has identified preliminary costs of renovating our primary disinfection process and until the project is funded and completed, will closely monitor operations to strive to lower TTHM and HAA5 levels. We will continue to sample and test TTHM and HAA5 at locations throughout the City and provide public notification as required.

We anticipate resolution of the problem within 15 months. If testing results show a reduction in TTHM and HAA5 levels, this will be identified in the next quarterly water system update. Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). #### **Secondary Notification Requirements**

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- SCHOOLS: Must notify school employees, students, and parents (if the students are minors).
- RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS (including nursing homes and care facilities): Must notify tenants.
- BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS: Must notify employees of businesses located on the property.

#### **BACKGROUND | ANALYSIS**

1. First Reading of Ordinance 587

In keeping with the job duties assigned to the City Clerk by the City Council in the City of Lindsay charter, the City Manager has directed the City Clerk to revise the provisions surrounding Title 13 of the Lindsay Municipal Code. Title 13 contains provisions primarily related to water, sewer, and refuse disposal services in the City.

Upon review, it was determined the City Clerk that the Lindsay Municipal Code required updates to better conform with the City of Lindsay's current processes as well as new state laws. For example, the current code states that water, sewer, and refuse disposal charges are issued and received by the City Clerk; that is not the case as those charges are processed by the Finance Department. Additionally, Prop 218 requirements state that service charges shall be determined in accordance with California State Law (Article XIIIC, Section 5.32.040 and 5.32.310). For clarity and transparency, this language was added to Title 13 of the Lindsay Municipal Code. For consistency's sake, regulations for delinquency charges and penalties for sewer and disposal services were updated to reflect current City protocol for water delinquency charges and penalties, which were amended in December of 2020 through Ordinance 585 to conform with Senate Bill 998 of the Water Shutoff Protection Act. Additionally, changes were made to the Lindsay Municipal Code requirement that water, sewer, and refuse disposal charges be "super-billed" in one combined bill.

All proposed amendments to Title 13 of the Lindsay Municipal Code contained in Ordinance 587 were submitted for review to and approved by City Attorney.



2-4. Minute Order Authorization for the City Manager to Execute an Agreement with Webb Municipal Finance; Information Items re Tulare County Property Tax Assessment Rolls

City staff is proposing that regular residential sewer billing and delinquent water sewer and trash billings be placed on the property tax assessment rolls beginning next fiscal year. The City currently bills trash, water, and sewer all on one bill to residents and is sent out monthly for the previous month's usage. If approved, sewer accounts and any delinquent water, sewer and trash would be billed twice a year in December and in April on the tax rolls.

It is mandated in the City's municipal code that all occupied households maintain water, sewer, and trash accounts. As part of this item approval staff has made the necessary changes to the municipal code for staff to move forward with tax roll billing as presented.

If approved, each fiscal year staff, along with the consultant, shall prepare the annual levy for sewer operation and maintenance charges for residential properties in the format acceptable for direct submission to Tulare County. Commercial accounts will continue to be billed monthly and will not be subject to change. Multifamily properties with one water meter will be billed as part of the tax rolls.

Although there are additional administration costs to place the assessment on the tax rolls this process is less expensive in the long run for the City and for residents. The cost to collect on the tax rolls is much cheaper than a collection agency, the percentage of bills being collected will increase, and less staff time is needed at the counter.

#### Delinquency

The total balance on all accounts past due is \$229,164.87, this includes water, sewer and refuse services. As of now delinquent bills are sent to a collection agency. The commission fee on collected monies is 38% or more depending on what legal action is taken on the individual account. If the city were to collect on the full amount past due through the collections agency it would cost the City a minimum of \$87,082 to recover the money. During the COIVD-19 pandemic the City has forwarded any accounts to collections.

#### Grants/community assistance

Staff believes that this is an excellent time to proceed with this item due to the availability of resources to the public. The Federal, State and City of Lindsay have already committed funds for utility and rental assistance through Community Development Block Grants, the American Recuse Plan and many others alike.



#### Timeline

#### April

• Approval from City Council to move forward with regular Sewer charges and delinquencies.

#### May/June

- Letters sent to property owners and account holders notifying them of the change.
- Consultant will meet with staff to gain understanding of the specific goals, components, and criteria to meet the City's needs.
- Consultant will obtain the latest assessor's parcel maps and equalized tax roll information from Tulare County for parcels.
- Hold public informational workshop.

#### July

- Staff reports, levy reports, resolutions and public hearing notices will be prepared.
- Notice of Intent posted as part of City Council agenda.
- Hold public informational workshop.

#### August

- Hold public hearing for final City Council Approval.
- Send all required documentation to Tulare County.

If approved by the City Council a public hearing and additional City Council action will be required later to place the levy for regular and delinquent billings. The resolution and a listing of accounts with amounts of assessment will be sent to Tulare County to be placed on the rolls and billed on the property tax bill in December and April of every year moving forward. Account holders would have a last opportunity to pay their accounts balance before the assessment is approved in August.

#### Public Outreach

If the City Council moves forward with the proposal staff is planning a series of public outreach measures. These measures include sending out letters in English & Spanish to property owners informing them of the change, what steps they may need to take and where to get additional information. Staff will also hold at least two (2) public workshops in person and via zoom to hold discussions and answer questions. If staff is receiving frequent calls and inquires additional public workshops will be added to address their concerns.

### **Timeline**

Approval from City Council to move forward with regular Sewer charges and delinquencies.

#### May/June

- Letters sent to property owners and account holders notifying them of the change.
- Staff will meet with the consultant to gain understanding of the specific goals, components, and criteria to meet the City's needs.



- Consultant will obtain the latest assessor's parcel maps and equalized tax roll information from Tulare County for parcels.
- Hold public informational workshop.

#### July

- Staff reports, levy reports, resolutions and public hear notices will be prepared.
- Notice of Intent sent out to account holders.
- Hold public informational workshop.

#### August

- Hold public hearing for final City Council Approval.
- Send all required documentation to Tulare County.

## FISCAL IMPACT

Revenue and costs associated with enterprise activities would be credited/charged from the appropriate fund. The contract cost for sewer operation and maintenance charge enrollment is \$7,500 and delinquent water, sewer and trash operation and maintenance charge is \$5,000. Tulare County's administration charge is estimated to be \$5000.00.

The total past due amount for water, sewer and trash is \$229,164.87. The final amount delinquent with be presented to Council as part of the final approval to levy.

#### AN ORDINANCE OF THE CITY OF LINDSAY

- AMENDING CHAPTER 4.320 OF TITLE 13 OF THE LINDSAY MUNICIPAL CODE, AMENDING BILLING;

#### THE CITY COUNCIL OF THE CITY OF LINDSAY DOES ORDAIN AS FOLLOWS:

**Section 1.** PURPOSE. The City Clerk, in keeping with the duties assigned to her by City Council, has revised the provisions surrounding Title 13 of the Lindsay Municipal Code.

**Section 2.** CODE AMENDMENT.

Lindsay Municipal Code, Title 13 is hereby amended to read as follows (text to be added in underlined, text to be deleted is in strikeout):

## 13.04.320 Billing

A. All water charges shall become due and payable to and at the office of the city clerkcity finance department on the first day of the month following the month of service and shall

- become delinquent on the twenty-fifth day of the month in which the billing occurs. When a bill becomes delinquent, a ten-dollar (\$10.00) penalty shall be automatically assessed. Water service shall be disconnected no sooner than sixty (60) days after the original due date, if the amount due and owing is not paid in full and the customer has not requested an alternative payment schedule or amortization plan. The City Manager shall enact and revise, as needed, a Residential Water Billing and Shutoff Policy not inconsistent with State law, the City Charter, or Municipal Code.
- B. All bills for such charges shall be issued by the city clerk. City Manager's designee. They shall be combined with bills rendered by the city in all cases where the premises in question is connected to the municipal water system. The bills shall state their purpose (water, sewer, disposal service) and shall give the name and last known address of the person responsible for the payment (as provided in this chapter) and shall list separately the charge for water service, the charge for sewer service, the charge for disposal service, and the total charge for all services. None of the charges may be paid separately from the others. If a premises is rendered one service and not another, a separate bill shall be rendered for the service or services so rendered.
- B.—All water, sewer, and disposal service charges shall be determined in accordance with Article XIIIC of the California Constitution and Section 5.32.040 and 5.32.310 of the Municipal Code and ratified by the City Council by resolution duly adopted.

## **13.04.340 Enforcement**

The <u>eity clerkCity Manager's designee</u> is charged with the enforcement of this chapter and all of its provisions, and all police officers of the eity shall be deputies of the city clerkCity Manager for such purposes.

- A. In the event of a violation of any terms of this chapter, or any rule or regulation established pursuant to this chapter, the <a href="eity clerkCity Manager's designee">eity clerkCity Manager's designee</a>, in writing, shall notify the person causing, allowing or committing the violation, specifying the violation and, if applicable, the time after which (upon failure of the person to prevent or rectify the violation) the city water superintendent will exercise his authority to disconnect the premises from the municipal water system and/or the municipal sewer system; provided, that such time shall not be less than five days after the deposit of the notice in the United States Post Office at Lindsay, California, addressed to the person to whom notice is given; provided, however, that in the event the violation results in a public hazard or menace, then the director of public works may enter upon the premises without notice and do such things and expend such sums as may be necessary to abate the hazard, and the reasonable value of the things done and the amounts expended in so doing shall be charged upon the person so in violation.
- B. Upon the failure of any person billed or the owner of a premises to pay any water service prior to delinquency, anyone or more of the following actions may, or where required by this section shall, be taken by the city or city officials to enforce the payment, subject to the provisions of subsection (A) of this section:

- 1. Each water service charge levied by, or pursuant to, this chapter on any premises within the city limits is made a lien upon the premises and any step authorized by law may be taken by the city to enforce payment of the lien.
- 2. In each case where any delinquency charges occur in water, sewer or refuse service, the <a href="eity-clerkCity Manager's designee">eity-clerkCity Manager's designee</a> shall assess a penalty of ten dollars in addition to the amount of the billing.
- 3. In each case where any bill for both-water service and sewer service remains unpaid as of the first Tuesday of the month(60) days after the original due date following delinquency, the city water superintendentCity Manager's designee, upon notification of such delinquency by the city clerk, shall disconnect the premises from the municipal water system, and he may also disconnect the premises from the municipal sewer system. Whenever a premises has been disconnected from either the municipal water system or the municipal sewer system, for nonpayment of water or sewer service charges, the premises shall not be reconnected to either the municipal water system or the municipal sewer system until all delinquent charges and penalties have been paid together with such reasonable charges for reconnection as may be ordered from time to time by the city council by resolution duly adopted.
- 3.4. Delinquent charges and penalties for water, sewer, or disposal services bills that remain unpaid as of (60) days after the original due date following delinquency may be levied onto a premises' property tax rolls upon approval by the city council.
- 4.5. The above rules and regulations shall apply, in equal force and effect, to charges and collections for sewer service and for refuse disposal service furnished by the city to any premises.

#### 13.04.360 Deposit

The nonowner of any premises, where a connection is made to the city water system or upon which city water is consumed, may be required to make a deposit of fifteen dollars or the amount of the minimum meter schedule charge, whichever is the greater, before water may be delivered to the premises. The deposit is made to secure the payment of the water bills and shall be refunded upon a change of occupancy, provided all water bills have been paid. The <a href="eity-clerkCity Manager's designee">eity-clerkCity Manager's designee</a> shall have the right to waive the requirements of a deposit for business or industrial consumers as may be deemed advisable.

### 13.04.380 Regulations Establishment

- 1. It shall be the duty of the <u>city water superintendentCity Manager's designee</u>, subject to approval of the city council, to establish rules and regulations applicable to the use of, and operation of, the municipal water system as may be deemed advisable and necessary; provided, that such rules and regulations shall not be in conflict with any provisions of this chapter and shall at all times be subject to appeal to the city council, whose decision shall be final.
- 2. It shall be the duty of the <u>city clerkCity Manager's designee</u> to collect all water service charges. The <u>city clerkCity Manager's designee</u> shall keep an accurate accounting and records showing the source, amount and disposition of all funds received from water service charges.

#### **13.04.400 Deposit Of Funds**

All revenues received and collected by the <u>city clerk City Manager's designee</u> pursuant to this chapter for water service by the city shall be deposited by the city treasurer within one month of receipt thereof by <u>him them</u> in <u>the appropriate Fund</u> a special fund known and designated as "utility fund" and all revenues received or collected by the <u>city clerk City Manager's designee</u> pursuant to this chapter or pursuant to Chapter 13.12 for sewer service shall be deposited by the city treasurer within one month of receipt thereof by them in <u>the appropriate Fund</u>. a special fund known and designated as the "utility fund."

### 13.12.040 Connection Permit Required

- A. No person whose premises are not now connected with the <u>municipal water system or</u> municipal sewer system shall connect any premises or cause any premises to be connected with the <u>municipal water system or municipal sewer system, respectively</u>, without first obtaining a permit to do so from the <u>City Manager's designeeeity elerk.</u>
- B. The eity elerkCity Manager's designee may require of any person who applies for any such permit to file a statement or affidavit for the guidance of the public works director, the city clerk and the city council in ascertaining the amount of the monthly sewer service charge payable by the person under this chapter. Each such statement of affidavit shall contain such information as may be required by the eity elerkCity Manager's designee. Failure by any person to file the statement or affidavit containing the required information shall constitute a violation of this chapter. No statement or affidavit shall be conclusive as to the matters therein set forth nor shall the filing of any statement or affidavit preclude the city from collecting from the person responsible for payment (as provided in this chapter) by appropriate action such sum as is actually due and payable for monthly sewer service charges under the provisions of this chapter. Each such statement or affidavit, and each of the several items therein contained, shall be subject to verification by the public works director or the city clerk City Manager's designee.

## 13.12.110 Charges; Billing

- A. All sewer charges shall become due and payable in a manner set by the city council by resolution duly adopted. become due and payable to and at the office of the city clerk on the first day of the month next succeeding the month of service and become delinquent on the tenth day of the succeeding month.
- B.—All bills for such services shall be issued by the eity clerk City Manager's designee. They shall be combined with bills or statements for water service and refuse disposal service rendered by the municipal water system in all cases where the premises in question is connected to the municipal water system. The bills shall state their purpose (water, sewer and disposal service), shall give the name and last known address of the person responsible for payment (as provided in this chapter), and shall list separately the charge for water

- service, the charge for sewer service, the charge for disposal service, and the total charge for all services. and shall list separately the charge for water service and the charge for sewer service and the total charge for both services. Neither charge may be paid separately from the other. If a premises with sewer service is not connected with the municipal water system, a separate bill shall be rendered for sewer service only.
- B. All water, sewer, and disposal service charges shall be determined in accordance with Article XIIIC of the California Constitution and Section 5.32.040 and 5.32.310 of the Municipal Code, and ratified by the City Council by resolution duly adopted.
- C. There shall be no exemption from the mandatory collection of sewer service.

## **13.12.130 Enforcement**

The <u>public works director City Manager's designee</u> and the city clerk are is charged with the enforcement of this chapter and all of its provisions. and all police <u>public safety</u> officers of the city shall be deputies of the public works director and the city clerk <u>City Manager's designee</u> for such <u>purposes</u>.

- A. In the event of a violation of any terms of this chapter, or any rule or regulation established pursuant to this chapter, the public works director or the city clerk City Manager's designee, in writing, shall notify the person causing, allowing or committing the violation, specifying the violation and, if applicable, the time after which (upon the failure of the person to prevent or rectify the violation) the public works director City Manager's designee will exercise his authority to disconnect the premises from the municipal water system and/or the municipal sewer system; provided, that the time shall not be less than five days after the deposit of the notice in the United States Post Office at Lindsay, California, addressed to the person to whom notice is given; provided, however, that in the event the violation results in a public hazard or menace, then the public works director City Manager's designee may enter upon the premises without notice and do such things and expend such sums as may be necessary to abate the hazard, and the reasonable value of the things done and the amounts expended in so doing shall be charged upon the person so in violation.
- B. Upon failure of any person billed or the owner of a premises to pay any sewer service prior to delinquency, any one or more of the following actions may, or where required by this chapter must, be taken by the city or city officials, to enforce the payment, subject to the provisions of subsection A of this section:
  - 1. Each sewer service charge levied by or pursuant to this chapter on any premises within the city limits is made a lien upon the premises and any step authorized by law may be taken by the city to enforce payment of the lien.
  - 2. In each case where any bill for both water service and sewer service remains unpaid for thirty days after the bill becomes delinquent, the public works directorCity Manager's designee, upon notification of the delinquency by the city clerk, shall disconnect the premises from the municipal sewer system. Whenever a premises has been disconnected from either the municipal water system or the municipal sewer system for nonpayment of water or sewer service charges, the premises shall not be reconnected to either the municipal water system or the municipal sewer system until all delinquent charges and penalties have been paid, together with such

reasonable charges for reconnection as may be ordered from time to time by the city council resolution duly adopted.

## 13.12.150 Public Works Director and City Clerk Duties City Manager's Designee

It shall be the duty of the <u>public works directorCity Manager's designee</u> to supervise all connections to the <u>municipal water system and</u> municipal sewer system and to establish and administer such reasonable rules and regulations applicable to the use of and operation of the <u>municipal water system and</u> municipal sewer system as may be deemed advisable or necessary; provided, that the rules and regulations so established shall not be in conflict with any provisions of this chapter and shall be at all times subject to appeal to the city council, whose decision shall be final. It shall be the duty of the <u>city clerkCity Manager's designee</u> to collect all <u>water service charges and</u> sewer service charges. The <u>city clerkCity Manager's designee</u> shall keep an accurate accounting and records showing the source, amount and disposition of all funds received from <u>water service</u>, sewer service or rental charges.

## 13.12.200 Air Conditioners; Funds Deposit

All revenues received and collected by the <u>city clerkCity Manager's designee</u> pursuant to this chapter shall be deposited by the city treasurer within one month of receipt thereof by <u>him them</u> in the appropriate fund. a special fund known as the "utility fund."

All other code sections in Title 13 of the Lindsay Municipal Code shall remain unchanged.

**Section 3. CEQA REVIEW.** The City Council hereby finds that this ordinance is not subject to review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15060(c)(2) [the activity will not result in direct or reasonably foreseeable indirect physical changes in the environment].

**Section 4. NO LIABILITY.** The provisions of this ordinance shall not in any way be construed as imposing any duty of care, liability or responsibility for damage to person or property upon the City of Lindsay, or any official, employee or agent thereof.

**Section 5. PENDING ACTIONS.** Nothing in this ordinance or in the codes hereby adopted shall be construed to affect any suit or proceeding pending or impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance or code repealed by this ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

**Section 6. SEVERABILITY.** If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or

enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this ordinance, or its application to any other person or circumstance. The City Council of the City of Lindsay hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more other sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable.

**Section 7. CONSTRUCTION.** The City Council intends this ordinance to supplement, not to duplicate or contradict, applicable state and federal law and this ordinance shall be construed in light of that intent. To the extent the provisions of the Lindsay Municipal Code as amended by this ordinance are substantially the same as provisions in the Lindsay Municipal Code existing prior to the effectiveness of this ordinance, then those amended provisions shall be construed as continuations of the earlier provisions and not as new enactments.

Section 8. EFFECTIVE DATE. The foregoing ordinance shall take effect thirty (30) days from the date of the passage hereof. Prior to the expiration of fifteen (15) days from the enactment hereof a certified copy of this ordinance shall be posted in the office of the City Clerk pursuant to Government Code section 36933(c)(l) and a summary shall be published once in the Porterville Recorder, a newspaper printed and published in the City of Porterville, State of California, together with the names of the Council members voting for and against the same.
