5. PRESENTATIONS

5.1 Wellness Center Events and Programming Update (*Armando M. da Silva*)

- Armando presented the following activities/programs/events:

- Dive In Theatre, this Friday at the Lindsay Wellness Center. Free to the community with funding from the Tulare County Step Up Program.
- New Aqua Zumba with Ana, at the Wellness Center, with an average of 20 participants.
- Youth Pickleball, Second Session finishes August 2. We had 6 participants in the first session, and currently, we have only 1 participant in the second session.
- Pickleball for Beginners continues to take place every other Monday.
- Swim Lessons are coming to a close. We've had a busy season of lessons.
- Pool rentals have increased compared to the past couple of years, along with the great room rentals.
- Skimmer's club has completed its season.
- Classes continue at the Wellness Center with significant participation.
- National Night Out will take place on Tuesday, August 5 at 6:00 p.m.

5.2 Wellness Center Memberships Update (*Armando da Silva*)

- Armando presented the Active Membership Summary, utilizing reports from the CivicRec software to highlight membership growth as of July 21, 2025, from 963 total members to 1,062 active members in approximately 3 months.

5.3 Wellness Center Facility Improvements/Capital Outlay Projects Update (*Armando da Silva*)

- Armando mentioned that he will be meeting with Neyba to create a 5-year list of CIP/COP projects for the Wellness Center. The following projects were mentioned:
 - Pool Deck and Therapy Pool Skimmers Renovation (\$600,000.00)
 - Pool Heater Replacement (\$30,000.00)
 - Pool Filtration System Update/Replacement (\$?)
 - Pool Trap Reel Power Drive System (\$55,000.00)
- Armando mentioned that it would be beneficial to refresh the Colorado system for swim meets and relays, although he expressed uncertainty about who would cover the costs.
- Councilmember Flores asked if the Lindsay Hospital District would be willing to help with some of these projects. Dennis Doanne responded that the project would have to be health-related, so the Pool Deck renovation wouldn't be funded. Armando printed a copy of his PowerPoint presentation, which he had presented to the LLHD Board regarding the funding of the Pool Deck Project for Councilmember Flores.
